"Circular Economy" first of all means recycling, therefore the activity of companies that produce innovation and environmental sustainability minimizing resource input and waste, emissions and energy impacts.

ReMade in Italy® is a non-profit, non-governmental organization aimed to promoting recycled products through independent third-party certification.

ReMade in Italy® was found in 2009 and in 2013 Accredia (Italian National Accreditation Body) recognized it as the first certification scheme in Italy and Europe to verify the recycled content in a product.

ReMade in Italy represents a useful tool for Public administrations and companies, to identify the recycled products for "Green public procurement", made mandatory in Italy by the law (Legislative Decree 50/2016).



The Association

The certification scheme is governed by a non-profit organization, legally recognized, gathering companies that realize recycled products in various category (building, street furniture, office furniture, schools, textiles and many more).

The Association is independent and reinvests revenues in institutional activities supporting Associated Companies for self-promoting on the public and private market and in strengthening the relationship with the competent Institutions.

ReMade in Italy® has been recognized as "good practice for Green Public Procurement" by the European Commission in the "Environmental Implementation Report – Italy" (February 2017).

ReMade in Italy® certification



ReMade in Italy® is the first accredited product certification in Italy and Europe to verify the content of recycled material in a product. Certification attests the traceability of production, starting from the verification of the source of input raw materials, to the finished product, representing a tool for transparency and simplification for Green Public Procurement and the private market.

For the public administration, certified products mean a guarantee of the environmental requirement on recycling materials and products for all sectors.

The independence of certification and “Green procurement”

ReMade in Italy certification is independent and recognised by Accredia: this means that the Association is not involved in any relationship between the Company and the Certification Body which make the audit. The Certification Body is observed and trained by Accredia, the only national Accreditation Body in Italy. This ensures maximum confidence in informations contained in the certification; that's why Remade in Italy certification can be used as evidence to participate in «Green Procurement» (mandatory by italian Legislative Decree 50/2016).

Steps of the Certification Process

1. Verify the requirements

In order to obtain ReMade in Italy certification, your product must be manufactured, even partially, with material from waste recycling. Read our Technical Disciplines and contact us for any information.

2. Choose the Certification Body

ReMade in Italy is an independent certification: you can choose one of the abilitated Certification Bodies (published on our site).

3. Do you need help

Depending on the complexity of the production process, it might be helpful for you to consult an advisor. Look at the list of qualified advisor on our website.

4. Set the Audit day with the Certification Body


Be prepared for the audit. It will take place in your factory for tracking the manufacturing process and analyze required documentation.

5. Did you get the certification? Use it!

ReMade in Italy® certification is accredited, recognized by the Institutions, and offers benefits in terms of participation in «Green Procurement».

6. Ask for label

Thanks to its eco-label, customers and consumers are able to identify products the environmental benefits of your product.



ReMade in Italy® label

At the end of the certification process, a label can be issued to the Company, showing product's recycled material content, with the assignment of the relevant class.

The label also explain the environmental impacts resulting from the recycling process, in terms of reduction of greenhouse gas emissions and energy saving in comparison with the production of the same item with raw materials.

The label can be directly affixed to the finished product, in its data sheets and Reports, for a strong communication with consumers, ever more environmentally aware.
